1. The Government of Nepal [GoN] has allocated funds towards the cost of Construction of Municipal Office Building and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Municipal Office Building (Contract No: 01691149). Bidding is open to all eligible bidders as per Section V of Bidding Document.
2. Temal Rural Municipality, Kavre invites sealed bids or electronic bids from eligible bidders for the construction of Construction of Municipal Office Building under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:  
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 58000000.  
Minimum Work experience of similar size and nature: 2 Number of 3,10,00,000.00 Each.

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Temal Rural Municipality, Kavre, Temal, Kavre, Thulo Parsel, Kavre, Nepal or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
5. A complete set of Bidding Documents may be purchased from the office Temal Rural Municipality, Kavre, Temal, Kavre, Thulo Parsel, Kavre, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 5000.0 NRs. till 04-06-2019 17:00 during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below.

6. Pre-bid meeting shall be held at Office of Rural Municipality at 03-06-2019 11:52 hours.
7. Sealed or electronic bids must be submitted to the office Temal Rural Municipality, Kavre, Temal, Kavre, Nepal by hand/courier or through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 05-06-2019 12:00. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 05-06-2019 14:00 hours at the office of Temal Rural Municipality, Kavre. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 1154650 which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
